**Please carefully read the criteria below before applying. We may request copies of proof of your eligibility to Educational Benefits if standard checks are unsuccessful. Please note that the criteria for the following benefits are correct as of June 2012 and are subject to change.**

### (A) Free School Meals

To qualify for assistance with Free School Meals your child must be in **full time education** and parent/carer's must be in receipt of one of the following benefits:

1. Income Support or Employment and Support Allowance (Income-related)
2. Income-based **not** Contribution-based Jobseekers Allowance
3. Child Tax Credit with an annual household income below £16,190 **and not** receiving Working Tax Credit
4. Support under part VI of the Immigration and Asylum Act 1999
5. Guarantee element of State Pension Credit.

## **(B) Assistance with School Uniform**

**Please note help is not available to children at primary school or children in Year 11.**

For assistance with school uniform, children must be starting Years 7, 8, 9, or 10 and the parent/carers must be entitled to Free School Meals through one of the qualifying benefits detailed in section A of this form.

Vouchers will automatically be sent out to those children in receipt of Free School Meals in June each year.

**Please note you are only entitled to one voucher per child per academic year.**

## **(C) Assistance with Home to School Transport**

To be eligible for assistance with home to school transport you must;

1. Be either in receipt of Free School Meals, or your maximum level of Working Tax Credit (have no reduction due to your income on this year's Tax Credit Notice). Your child must also be attending one of the three nearest schools with places available, which is between 2 - 6 miles from their home address.

2. Fulfil the criteria under the City of York Home to School Transport Policy (details of which are available at [www.york.gov.uk/schooltransport](http://www.york.gov.uk/schooltransport))

**If you are not entitled to Free School Meals, please attach a recent copy of your Tax Credit Notice. For secondary school applications please enclose a passport sized photo.**

If you require short term assistance due to exceptional circumstances such as illness please outline your requirements below and attach any supporting documentation from social workers or medical practitioners.
